1. **Setup/Breakdown**: All Exhibitors must be set up and ready to sell by 8am on the day of the event. Exhibitors may begin setting up at 7am the day of the event. Break down can start no sooner than 2pm on Saturday and must be completed by 4pm. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces. *Before leaving, be sure your area is clean and trash-free. If you are staying for Sunday, you will need to move your booth inside for overnight.

2. **Staffing**: Exhibitor tables/booths should be manned at all times and intact until event closes at 2pm.

3. West Metro is not responsible for merchandise or display materials.

4. West Metro reserves the right to have items removed that are considered inappropriate.

5. **Exhibitor Responsibility**: Exhibitor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. West Metro expressly disclaims any responsibility for same. Exhibitors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each exhibitor is responsible for the conduct of his employees and/or representatives and activities must not detract from the image or welfare of the event.

6. **Exhibitor Spaces**: If you have special space needs, please include your request with your application and we will make every effort to accommodate you. Spaces are reserved on a first-come first-served basis. No refunds will be made for weather, accident, health or other causes for non-participation.
